BACKGROUND

Aggrow Farmers Development Organisation ("Organisation" or "Aggrow" or "AFDO") is a non-Government, non-political, not-for-profit organisation engaged in the field of agri related activities.

LEGAL STATUS

Aggrow Farmers Development Organisation is incorporated under Section 8 of the Companies Act, 2013 on 18 May 2020, bearing Section 8 Licence number 118505. The Company is authorized to receive CSR funding and holds 80G exemption certificate.

OBJECTIVE

The objective of Aggrow is to deeply engage with the farming community and work on design, implementation and capacity building of climate resilient agriculture projects, which will provide sustainable livelihood to farmers by improving soil health and quality of produce and reduce impact on the environment.

AGGROW'S VISION FOR IMPACT

The Indian Government is increasing the focus on the marginal land-hold farmers by taking up a Vision Policy of Doubling Farmers Income by 2024. To aid Government of India in its Vision, Aggrow has zeroed in more than 30 growing belts in Southern India wherein it will seek to intervene and activate participation with the Indian Central & State Governments.

Aggrow is envisaging active strategic engagements, to begin with, the three State Governments in Southern India – Andhra Pradesh, Tamil Nadu and Karnataka through a Public Private Partnership structure and with this initiative will deepen the engagement with the multiple State Governments.

ACTIVITIES UNDERTAKEN IN FY 2023-24

During FY 2023-24, Aggrow expanded its operations to newer geographies like Krishnagiri, Hosur, Salem districts, taking the total number of operating areas to 8 districts.

By the end of the financial year, we had 33-member strong team, spread across Nilgiris, Coimbatore, Salem, Hosur, Krishnagiri, Mandya, Chittoor and Vishakapatinam Districts. The team comprises of 2 doctoral degree holders (in Agriculture field) who are ably supported by a team of experienced agricultural diploma, degree & post graduate degree holders, apart from admin and support staff.

The following are the major activities carried out by the Organisation during the year:

Credit Access

Aggrow helped small and marginal farmers in accessing credit for their farming activities. The loans were facilitated in a paperless manner from a fin tech company. Aggrow's team was trained to assess the farmers requirements and facilitate access to credit on a timely basis. Aggrow supported more than 1,500 farmers in accessing credit upto Rs. 2 lakh per farmer (depending on up the vegetables being grown) in FY 2023-24.

Farmers who otherwise would not have the capabilities to digitally apply for such loans could do so with the minimum amount of documentation with Aggrow's support.

Inputs

Aggrow's team of agricultural extension officers carry out soil testing and recommend the suitable crops as well as inputs that should be used for crop cultivation. In the year FY 2023-24, more than 1,600 soil testing activities were carried out and results given to farmers.

Training and capacity building activities

More than 250 farmer meetings were conducted in FY 2023-24. Meetings were also conducted with many farmer producer organisations in Ooty, Mettupalayam, Chittoor and Mandya Districts. The objective of these meetings is to educate the farmers on the latest farming techniques/ practices, new inputs available in the market, credit facilities, Government / Horticulture Department schemes & programs, etc.
